When a person has been injured at work or in a transport accident, dealing with insurers can be baffling and frustrating not just for the injured person, but for their medical caregivers. This presentation will address in what circumstances a WorkCover or TAC claim will be accepted, how to access the best medical care under the scheme, how your patient can appeal a decision they are not happy with and how to ensure your patient is protected financially in the long and short-term following injury.

Opioid Prescribing: Pearls and Pitfalls Dr Gavin Weekes, Pain Specialist

Prescribing opioids can be difficult. This presentation aims to guide GPs to safe and effective prescription of opioids, and provide an update on the current issues surrounding opioids. Treatments available for chronic pain conditions have changed dramatically in the last decade- newer pharmacological options will also be discussed. **Learning outcomes:**

- Identify safe strategies for opioid reduction and other pharmacological treatment options
